I will be going in there Wednesday morning. And, yeah, outside of that financial situation, I mean, not fantastic, but not horrendous. I think we found a nice middle ground up, like, halfway decent. So I'm fired up about that. Yes, Dana, I will chase them down. Haha. But yeah, so that's kind of where at with that stuff, and I think that is all I have.

That's just kind of my step all right now of like an action item for this situation.

And so that's something that I think I've seen this committee over my time here do a much better job at is actually like asking for the minority opinion in a way that's real and not just because Robert's Rule tells us to. But something to keep in mind as we have any discussion. Whether it's a voting member or not. That sometimes the quiet voice can get drowned out or just maybe not even speak up because we have a lot of strong voices here. And that's good. But making space for everybody to weigh in. And then on the flip side of that was the encouragement that I think actually I talked about, and this was a holdover from my time at District where we would have really insightful people with a lot of experience but were like too afraid to speak up or too shy or too intimidated or whatever. So the reminder for anybody who's sitting there with something that they really want to say that they maybe feel like the group should know and might either alter the course of the boat or at least bring some new information to it. It's really all of us being here on advisory, it's on us to make sure that we are speaking up and saying those things that we need to. And if we have a question to ask questions so that we can be fully informed, so that we can vote on whatever it is that we're talking about. So that was what we had for underline do we understand the spiritual principles underlying the right of participation? I think the gist is we all understand it. It's just a matter of actually like living it. Jones, comments concerns?

Because stuff like that the group conscience doesn't need to know my opinion about that stuff in that way for them to make a decision when we're making a decision, it's supposed to be an informed decision based off of experience. And just because I think something is a waste of time, usually it's because I just don't have experience with it. And that's something that I've gained through humility in alcohol synonymous. It's just something to think about because when we're talking about that, we're talking about things that are pressing the minority opinion or the quieter voices and we don't want it to turn into mob rule, which I've seen happen before. And that becomes intimidating and not only just for that time, but every time after that people begin to struggle more and more about speaking up when stuff like that happens.

But of course, post, we revisited, as if there's revenue the first thing. Like, this is their first financial commitment outside of the bills to actually have the conference. So it's kind of like revisit post conference with disbursements, and then hopefully we get that money back, which I would love to see good to do. Moving down to expenses, the things that have changed since last time I presented a budget increase in treasury expenses. Expenses checks are expensive as fuck. Apparently. I learned that. And so I had increased the amount of money that we were going to need in order for us to get a new checkbook for the advisory account and to get a checkbook for the host formerly Host Seven, soon to be Host Nine account, because they will need checks for things. Host Eight we don't have to worry about because Mo ordered those.

So those are coming out of their operating expenses for this year. And then our good old travel situation. The big crux of our conversation with where we are financially, it's not that I'm opposed to the concept of travel stipends. I just believe that the numbers don't lie and we legitimately just don't have the money for them. We have zero income. We went negative on the we lost money on mid year. I forgot to update that. So we've made zero money this year, and we are spending our Prudent reserves. So, because of those reasons, I feel like we can't afford travel stipends this year. Now, by all means, if for some reason that changes in the next several months, I'm not opposed to revisiting this and making those changes. This is not set in stone. But with our current financial situation, I don't believe we could afford it because we have \$7,000 in our bank account right now and still have about \$2,000 worth of expenses that have not gone out. And, yeah, that's where I'm at. So I would like to make a motion to approve the budget as presented. And I'm going to stop sharing my screen.

Okay, we got one. Is there anybody else? Okay. All right, Adam, could you give us a brief service resume? And can you put a smile on that face for me?
