They're having their meeting tonight. We said that we would connect probably tomorrow. And yeah, we'll go from there. We had a bylaws revision call this evening. It did not happen to be the last one. So we are not in a position to present the bylaws, the revised bylaws to the group. They're just not guite ready yet. Keep an eye out for that to be finished. When it's finished, we're going to discuss the physical address of the bank account. We are going to discuss seating arrangements for the main meetings. We're going to be electing an outreach share. We will start the discussion on disbursements, just general points of reference. And we will be doing tradition and concept tonight as well. So that's what our day is looking like. Any questions before we move on to co chair and treasury report? Okay, thank you. Go ahead, Bob. Thanks for sending agenda, Bob.

So since our last call, host brought in \$929.58 registrations. They brought in \$120.10 from precon sales \$22. And seven tradition spent \$875 on the deposit for the AV. So overall balance is 30,000 689. One. We are 89% of our budget covered. Shout out to Ryan, the registration chair by cutting his budget by \$764.98. So we still need 4585 78 to pay for the rest of our expenses. We need 14, 24, 35 in order to our precon expenses. So that's where we're at financially. Our account and the host nine account are left unchanged. Nothing's happened in the last, like, three weeks with that since I transferred money. So, yeah, that's the treasury shenanigans.

Hi, Jeff. Alcoholic. And I'm such an alcoholic that I forgot that I was doing this. Which Is fine, because I'm pretty sure I understand it enough to give you a little summation of it. So let me be responsible and go to some type of literature so that I can pull it up and read it right. I'm irresponsible, sick, alcoholic, and I forget about shit. So sorry. Not sorry. All right, here we are. Every AA group out to be fully self supporting, declining outside contributions. So when I first came into the rooms I joined a very small AA group in a small town outside of Binghamton with about five members, and they made me their treasurer immediately, without even a question, they said, here's the treasury and the key. Adam and I were the youngest members of the group by, like, 40 years of age and sobriety. So they were just excited to have some young folks come along to take over everything. So I learned very quickly, like, what had to be done. So it was one of those small groups that a bank account. So I had to set money aside, and I had to learn. And these old timers taught me, like, make sure that their supplies, make sure that the rent is paid, make sure that we're donating to Alcoholics Anonymous. And then as I progressed in my sobriety, I started to want to learn more about the traditions. And I got a sponsor who was very traditional, strong, and there's a couple of different forms of this, or opinions, I should say.

I had a sponsor named Tom Stewart who told me that when he reads this. The way that he takes it is that self supporting means that your group should be taking AA's money and buying stuff with it. That we should be putting that money in a basket separately at our group conscience to pay for supplies and rent. And that the money that AA members are putting in the basket at your meeting should be donated back into AA to support Alcoholics Anonymous. And I like that a lot. Unfortunately, my group doesn't abide by that. I would like them to, but that's not something that ever gets voted in when I'm trying to make that happen. So I accept the group conscience for the vote that it is. But in my opinion, self supporting means that we should not be taking money from other AA members and spending it on other things other than a economy is a beautiful thing. So as far as this goes for me, I've had a pretty terrible experience with figuring out financial stuff at the end of my host year, which turned out to be a great learning experience for me and helped me understand a lot of stuff that I thought I knew. And when I hear a group say, you know, a is fully self supporting, I feel like I don't like to put my money in the basket at every meeting because I don't know where that money goes. And being involved in general service has helped me realize that not every AA group is going to help AA out. And that's okay. My home group donates their money back into Alcoholics Anonymous because it's very important to me and to my group that AA is supported and that I know the information. Like, the GSO is always living on their Prudent reserve because we don't give them enough money because they still people are still putting a dollar in the basket when really we should be putting, like, \$13.25 each in the basket to match what it was happening in the 1940s. And, yeah, nobody ever wants to talk about money. It absolutely sucks. I hate talking about it. It makes me uncomfortable. But for me, the 7th tradition means that we should be supporting our groups, and the money that we collect from other AA members in our group should be supporting Alcoholics Anonymous. That's my interpretation of the 7th tradition. It may not be everybody else's, and I respect that, and I'm all for hearing other opinions. And again, sorry that I'm a forgetful old man and I totally forgot about this, and I just absolutely love being here. Thank you so much. I love you guys.

I know enough about it, so I'm just going to read it. Concept seven. The conference recognizes that the charter and the bylaws of General Service Board are legal instruments that the trustee are thereby fully empowered to manage and conduct all of the world service affairs of Alcoholics Anonymous. It is further understood that the conference charter itself is not a legal document, better owes instead upon the force of tradition and the power of the Aapurse for its final effectiveness. Just in short, to simplify, the board can override the conference when necessary. Essentially, it places it's kind of like, how is this actually applicable? When I hear the concepts, I'm just like, what does this even mean? And what it really is kind of how it relates to my life. And most of yours, if you're on advisory, is it's saying that the host committee has autonomy but advisory can step in? And AA needed this because it's a bunch of alcoholics running around and they needed a separate trustee board to make sure that they didn't screw everything up. So it's kind of the balance of power in a nutshell to keep everybody in check. And I hope that simplified it for everyone, and that's what they have to say today.
