During the discussion I reminded Todd that there was still a \$1000.00 deposit for the Crown Plaza that was still owed to the Advisory account and that there was a \$2000.00 amount that was there for Chase banking purposes.

I also received a Host 9 budget and sent it to all members via email.

On 2-18-23 I gave Erin the debit card information so she could reserve the 10 sites at Schodak State Park for our Mid-Year Event May 6-7. Each site was \$19.00 with a \$7.25 reservation fee. Total was \$262.50.

All debit cards have been activated and are ready for future use.

- We had a motion to have host reimburse us the \$1865 we lent them for a deposit that motion passed.

Hotel: Host 9 Hotel Chair has stepped down from the position so it is open currently. Todd and Cindy are currently bring the fill in hotel chair with my assistance when needed.

Fri 9/15/23---25 room nights
Saturday---26 room nights
Total currently is 61 room nights booked.
Current Attrition Rate is 24.6%

- We need to get to 248 room nights booked in order to meet the 80% Attrition rate out of a total of 310 room nights.
- There were another 11 room nights that were added to Thursday 9/14/23 for a Total of 21 room nights. 9 of those have been booked which leaves 2 room nights left. I have not included these yet because I need to ask if these rooms booked get applied to help with our attrition rate.

Todd and I will be making arrangements to have a formal meeting with Lexi from the Crowne Plaza in the coming weeks. Then the committee will be making a plan after which to have a walk thru done so everyone can see what the conference center looks like. This Host Committee needs our support in getting Hotel rooms booked. No Deposit is required to hold the room. If you know of anyone who is going to ESCYPAA 9 who hasn't booked a hotel room yet please tell them to do so.
