They want to have it all setup prior to us arriving. When I get to the hotel on the 14th I have to sign for the 3 keys at the front desk. I will have one of the 3 keys to the boardroom and the other 2 will go to Meg and Cindy on Host. We can't lose these or we have to pay \$50 per key to replace.

I also have been in contact with the Oncenter and everything is set. They need the insurance policy by Friday September 1st. Cindy is aware and I will continue to remind her of this.

I have been in contact with Rocypaa, Craypaa and HVYPAA about Hotel Proposals and have been helping answer questions and keeping up to date with everyone.
