Treasurer: Hi everyone,

Bank Account balances:

- ESCYPAA Advisory: \$6,750.08
- ESCYPAA XII: \$4,770
- ESCYPAA XIII (active future host): \$2,000

Please note that \$2,000 is the required minimum and belongs to Advisory, so that amount isn't available for use.

I'd like to discuss the possibility of moving to two bank accounts total: one for Advisory and one for the active ESCYPAA Host, rather than keeping accounts for future hosts.

All disbursements have gone out. ESCYPAA XIII Bank account is officially active as future host account, and I am currently waiting to receive the annual ledger from ESCYPAA XI for records.

I also want to clarify that I asked the Host Treasurer not to spend any additional funds until the budget is approved by Advisory. Eric let me know that technically no Host funds have been spent, and that the money used for merch came directly from SYRYPAA, not from ESCYPAA accounts.

Host will be approving their budget tomorrow night, and Eric will send it to me once it's approved. I'd like to call an emergency business meeting sometime this week to approve the budget. Please let me know at the business meeting what everyone's availability is for this week to attend an emergency business meeting.

Lastly, I'll be motioning tonight to add Maysam and Eric to the bank account.
